

JOINT RESOLUTION REVISING THE OKLAHOMA CITY AIRPORT TRUST'S MISCELLANEOUS FEES SCHEDULE, EFFECTIVE OCTOBER 1, 2025.

WHEREAS, the Oklahoma City Airport Trust ("Trust") is a public trust created pursuant to its Trust Indenture and under the authority of the laws of the State of Oklahoma with the City of Oklahoma City ("City") as its sole beneficiary; and

WHEREAS, the Trust leases, manages, and operates certain real estate for the City, more commonly known as OKC Will Rogers International Airport, Wiley Post Airport, and Clarence E. Page Airport (collectively, "Airports"), which are located in Oklahoma, Canadian, and Cleveland Counties, Oklahoma; and

WHEREAS, the Lease Agreement between the City and the Trust provides for the City's approval of any uniform rates, fees, or charges to be imposed by the Trust; and

WHEREAS, the Miscellaneous Fees Schedule includes a progressive three-year plan with annual increases to some of the charges; and

WHEREAS, the fee increases are driven by an increase in activity, inflation and the rising cost of supplies and services; and

WHEREAS, this Miscellaneous Fees Schedule will take effect on October 1, 2025, and some of the fees will have annual increases on July 1 for the fiscal years 2027 and 2028; and

WHEREAS, this Miscellaneous Fees Schedule beyond June 30, 2028, will remain at the FY 2028 rates until a new Joint Resolution is adopted.

NOW, THEREFORE, BE IT JOINTLY RESOLVED that the Oklahoma City Airport Trust hereby adopts the revised Miscellaneous Fees Schedule attached hereto, effective October 1, 2025, and The City of Oklahoma City consents to the imposition of such fees to users of the Airports.
